10:14 a.m. Dispensaries — Patient Registry (Reed)

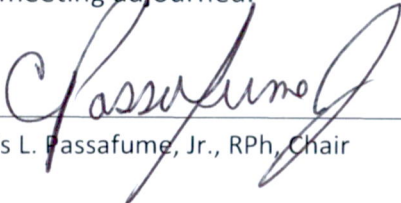
Ms. Reed presented an update on dispensaries and patient registry.
